**RESOLUTION OF THE BOARD OF DIRECTORS OF
GABRIELS OVERLOOK P.O.A., INC.,**
Regarding self-help action (force mows, etc.)

WHEREAS the Board of Directors of **GABRIELS OVERLOOK P.O.A., INC.**, (the "Board" and "Association," respectively) is charged with the duty of overseeing the administration of the Association, including but not limited to the enforcement of the deed restrictions and the remedy of violations of the deed restrictions;

WHEREAS the Association has engaged the services of Alliance Association Management to perform day-to-day administrative tasks and coordinate the enforcement of deed restrictions on behalf of the Association; and

WHEREAS the enforcement of deed restrictions and ability of the Association to remedy violations of the deed restrictions as provided in the governing documents is critical to the maintenance and preservation of the community, and as such the Board desires that deed restrictions are enforced and violations remedied with a minimum of delay;

THEREFORE the Board has RESOLVED that if a violation of the deed restrictions that can be cured or partially cured by self-help is noted, Alliance Association Management and any successor management company retained by the Association shall have the authority without further Board action, unless otherwise directed on a case by case basis by the Board, to pursue the self-help remedy (such as force mows, trash removal, etc.) as provided in the governing documents of the Association (See Declaration Section 3.06, requiring 15 day notice of intent to undertake lot cleaning (force mow, etc.) on behalf of owners). All such amounts incurred, per the declaration, represent a lien on the owner's lot.

AGREED TO and RESOLVED 22nd day of May 2012 at a meeting held via conference call at which all board members were present and this resolution was unanimously adopted.
